Policy Document **Match Fixing Policy** **Betting, Result Tampering and Corruption**

Authority: SAISA Inc Board

Application: This policies applies to SAISA Inc and all of its affiliates

INTRODUCTION

It is recognized that betting is a legitimate pursuit, however illegal or fraudulent betting and the associated Match-fixing is not. SAISA has an obligation to address the threat of Match-Fixing and the corruption that flows from that.

This policy applies to, and is binding on, SAISA members, affiliated Clubs and their members and includes teams, volunteers, judges, officials, employees and coaches.

PURPOSE

The purpose of this document is to protect and maintain the integrity of the sport and to protect against any efforts to impact improperly the result of any event.

GOLDEN RULES

Protect yourself against corruption by following these principles:

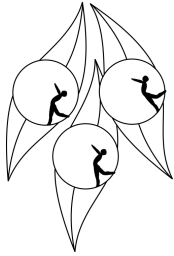
- Be Smart: know the rules
- Be Safe: never bet on your sport
- Be Careful: never share sensitive information
- Be Clean: never fix an event
- Be Open: tell someone if you are approached

Policy

The 'Don'ts':

Members of SAISA, their affiliated clubs and their members, judges, officials, coaches, volunteers, employees **MUST NOT**, whether alone or in conjunction with another or others, directly or indirectly breach this Policy or the sport's Code of Conduct by:

1. Betting, gambling or entering into any other form of financial speculation on any SAISA or ISA competition or on any event connected with any SAISA or ISA competition; including,
 - a. Inducing or encouraging any other person to do so; or,
 - b. Offering the facility do so.
2. Participating (whether by act or omission) in, or being a party to contriving or attempting to contrive the result of any SAISA or ISA competition or series of

competitions or other events in exchange for any benefit or reward (other than a benefit or reward received from SAISA or ISA) by:

- a. Deliberately underperforming or 'tanking' in any event;
- b. Deliberately fixing, or exerting any undue influence on any occurrence within an event;
- c. Inducing or encouraging any person to deliberately underperform in any event;
- d. Providing inside information that is considered to be information not publically known such as Team or its members situation or programs;
- e. Ensuring that a particular incident, that is the subject of a bet, occurs;
- f. Providing or receiving any gift, payment of benefit that might reasonably be expected to bring the sport into disrepute;
- g. Engaging in any conduct that relates directly or indirectly to the subject of this Policy and may be prejudicial to the interests of the sport or its members.

The 'Do's':

Members of SAISA, their affiliated clubs and their members, judges, officials, coaches, volunteers, employees MUST:

3. Promptly disclose to the SAISA Board:
 - a. That they have received an approach from another person to engage in conduct, such as described above, or,
 - b. That they know, or reasonably suspect that any current or former skater or official or any other person has engaged in conduct, such as described above, or,
 - c. That they are aware that another person has been approached to engage in conduct, such as described above.

Failure to Comply:

4. Failure to comply with any matter covered in this Policy or the Code of Conduct of the sport may result in sanctions by being applied in accordance with the provisions in the SAISA and ISA Constitutions and By-Laws (however described).
