

Policy Document SAISA Scholarships 2016 -2017 High Performance & Junior Development International Events

## INTRODUCTION

Wherever financially viable SAISA assists its members to attend international events as approved by Ice Skating Australia. Financial assistance is in the form of a Scholarship and is paid in arrears of the event and at such time as the athlete has demonstrated a return to the sport and has met the obligations outlined in this Policy.

## PURPOSE

This policy outlines the guidelines for athlete scholarships to International events in the 2016 - 2017 International Skating Season and is valid for the current season only: it commences May 1 2016 and terminates at 30 April 2017. The Policy will be reviewed after the close of the 2016 SAISA Financial Year.

## POLICY


Athletes must be current financial members of SAISA.

Athletes must meet the residency provisions and eligibility requirements for South Australian Championships and subsequent selection to the State Team progressing to the Australian National Championships.

Athletes must have met Ice Skating Australia's (ISA) requirements to compete in International events.

Individual Athletes may be competitors in Singles Skating or be part of an Ice Dance couple or Pair. Where athletes in an Ice Dance couple or Pair belong to different Associations and have different residency status, only the eligible South Australian member will be considered for a scholarship. Synchronized Skating Team members must all be eligible SAISA members.

Athletes/teams are eligible for funding for International Events as in the table below. The maximum scholarship amount is listed along with the athletes' obligations:
