Cancellation of ISU Seminars and Meetings

Ladies and Gentlemen,

On March 12, 2020 the ISU Council decided to cancel a number of meetings and seminars that were due to be held in March, April and May 2020.

Due to the continued and increasingly negative Coronavirus/ COVID-19 developments, the Council has further reviewed meetings and seminars scheduled to be held between June and August 2020 and decided to cancel all meetings and seminars planned during the period until the end of August 2020.

A rescheduling of the above-mentioned meetings and seminars will be evaluated once the situation again allows the planning of safe travel. The possibility of rescheduling some of the meetings and seminars online is also currently under assessment.
